A. Reappointment to the Economic Development, Tourism, and Film Commission

Departments: Economic Development

Reappointment of Florene Trainor to the Mono County Economic Development, Tourism, and Film (EDTF) Commission.

B. Mono County Behavioral Health (MCBH) Performance Contract with the Department of Health Care Services (DHCS) for the provision of Behavioral Health Services from July 1, 2026 to June 30, 2029

Required contract between MCBH and DHCS for the provision of behavioral health services.

Recommended Action: Approve agreement with DHCS for the provision of behavioral health services and authorize Behavioral Health Director to sign agreement on behalf of the County.

Fiscal Impact: There is no fiscal impact to the County General Fund. The County Performance Contract ensures continued receipt of MCBH's budgeted revenues from DHCS to support the delivery of behavioral health program services.

C. First Amendment to Contract with Community Service Solutions for the Provision of Housing Programs Outreach and Engagement

Departments: Health And Human Services

Community Service Solutions (CSS) conducts housing programs outreach and engagement on behalf of the Mono County Health and Human Services (HHS) Department under an existing contract. HHS would like to amend the current contract to allow CSS to provide additional services for the County, including certain newly required administrative functions and coordination of contractor services for limited-scope housing habitability projects.

Recommended Action: Approve first amendment to contract between Community Service Solutions and County for provision of housing programs outreach and engagement by extending the term of the contract until June 30, 2028, increasing the contract limit from \$90,550 to \$342,913.77, and modifying the not-to-exceed amount in any twelve month period from \$90,550 to \$160,000. Authorize the Mono County Administrative Officer to sign the amendment.

Fiscal Impact: The amendment will increase the contract limit from \$90,550 to \$342,913.77. The funds to pay for the increase are made available through the California Department of Social Services housing program allocations to Mono County Health and Human Services.

Fiscal Impact: The fiscal impact of a potential internship varies depending if the opportunity is paid or unpaid (volunteer basis). Paid internships may be funded by the College or by the County, and will be budgeted for accordingly in each fiscal year. To fulfill the work experience (internship) hours required by the college costs about \$2,300 per student, and will be budgeted for as funding comfortably allows. MCSOAR will continue to search for funding opportunities that support this cost. For FY25-26, this internship is funded by staff savings, grant funds, and state funds.

Proposed Resolution Stipend Program for Recreation Division Employees and associated Side Letter establishing and outlining parameters for a stipend program for certain employees within the Recreation Division. This stipend is intended to help attract and retain more skilled, quality employees, interns and / or volunteers within the outdoor recreation industry, which has become difficult over the past several years and impacts the County's ability to perform expected duties. By providing these employees with a modest stipend, the Recreation division will increase in productivity and efficiency, and can potentially increase the amount of workforce better able to afford living and working in (and for) Mono County long-term.

Recommended Action: Adopt proposed Resolution Stipend Program for Recreation Division Employees and associated Side Letter.

Fiscal Impact: A stipend program is being requested for select Recreation Division employees to increase the quality of skilled and industrious employees, which will in-turn increase division efficiency, productivity, and quality of work. The overall stipend program is written with a seasonal limit of \$10,000. For the 2026 season (FY25-26 May - June and FY26-27 July through October), an initial pilot stipend is proposed in the approximate amount of \$7,200 (\$1,000 - \$1,200 per seasonal employee) (approximately \$2,088 in remainder of FY25-26 and approximately \$5,112 for July thru October of FY26-27) to be awarded on a prorated basis (rate of \$10-\$12 per work day depending on position type). This stipend will be funded annually by the Geothermal fund, as funding allows, reviewed annually at time of budget development, and through grants as available.

D. Golden Mussels Update and Fish & Game Fine Fund Application
